# In Our Mothers' House Returned to Davis County School District Shelves

I was so excited to have Patricia Polacco's *In Our Mother's House* placed back on the library shelves in Davis School District that I called and texted everyone I knew. My children were among the first that I contacted, having lived the whole situation with me for months.

While I raised my daughters, I worked full time and went to school full-time for a number of years. Their father was out of town most of the time. After I graduated, I got divorced and needed to work part-time as well. I was not home to monitor what they read, watched, or looked at on the computer. We talked about how they needed to decide for themselves whether it was something that would help them make good or bad choices. When others questioned what they chose, I defended their right to choose it. They all developed the ability to choose the good and reject the bad (Freedom to Read statement) and also gained an appreciation for their First Amendment rights.

When making our "50 State Salute to Banned Books" video last year, we needed to cast a couple of different families to fit the script. I asked my oldest daughter for several reasons, besides the fact that I thought my grandkids were amazing. I knew she was a great supporter of the Freedom to Read. She and the kids had a great relationship with her uncles, so the subject of the book would be comfortable. I was trying to have input from several Utah counties.

When I told her about Sweater Vest Sunday, she thought it was a great (fashion) statement. We

offered a Kindle Fire for those who sent in in their picture. It was an easy contest, and the five year old winner was pretty excited. You might recognize him from the video: he is the shy one. My daughter said maybe now he will be interested

in learning to read. Maybe the older siblings will read to him, just to use it. It's my hope that my grandchildren always feel free to read what they choose. Whether it's only *Star Wars* books or Stephen King, whether they are in Utah County or Davis County, whether they go to a library in Salt Lake City or Salt Lake County, I am going to fight to make sure that they have the rights that they believe they have. I will also never stop trying making sure everyone understands what they are.

# **Blanding Library Completes Renovation**

The San Juan County Library System has just completed a \$500,000 renovation on the Blanding branch library. The Blanding Library was built in 1962. With very little work being done on the library over the last fifty years the library now looks sleeker and is greener. The library received a new roof, heating and cooling system, windows, electrical and lighting, carpet, and removed an interior wall to expand the usable library space. The reaction from the community has been overwhelmingly positive.

San Juan County Library paid for this renovation with a USDA Rural Development grant of \$200,000 and a budget surplus that the library has managed and saved carefully over the last ten years. The library has used the space to add more computers, tables, and more shelves for books. It is a wonderful facelift for the library and allows the library to better serve the community.

TEi-Library Services maintains:

 Standards, published by UL, AWS, NFPA, ANSI, ASTM, ISO, IEEE, NEMA, ASSE, ASME, BSI, TUV and many others.

- Technical documents by industry sources such as ASME, IAPMO, CSA and others.
- Books on subjects such as quality control system establishment, and others.

Material checked-out from TEi-Library Services must be returned. The loan period is one month from the date of check-out. The loan period may be extended once for an additional two weeks. Loan extensions are accomplished by sending a request via fax, mail or e-mail, and must be received one week prior to the due date.

TEi-Library Services is a for fee library. Terms and conditions apply to checking out a standard. Contact TEi-Library Services for details.
