Charge

The ULA Copyright Education Committee discusses, explores, and educates ULA members on the full range of copyright and helps create a consistent understanding of the core rights that make up copyright along with the range of exceptions as they relate to libraries, readers, teachers, and learners.

Approved by the Board on June 3, 2016. First committee meeting held August 1, 2016 to develop guidelines, goals, and objectives as stipulated in ULA bylaws.

Guidelines

- The committee consists of a chair appointed by the ULA president and a vicechair selected by the committee from a library type different than the chair's. The committee consists of up to ten members from as many types of Utah libraries as possible (public, special, academic).
- The committee maintains the Copyright Information page on ULA's website
- The committee strives to offer at least one educational event every year either at the Annual Conference, Fall Seminar, or as a standalone program.

Goals & Objectives for 2016-2017

- 1. Populate a committee and "Copyright Information" page on ULA's website
 - Include wording from statute showing core rights
 - List relevant exceptions o Reference local policies as much as possible
 - o Include case law
 - Build listing of permission-free resources
- 2. Build the membership to include librarians from Public and Special libraries

 State Library. Various topics were discussed at our first meeting.

Chapter Councilor ALA

ALA Chapter Report, September 2016

ALA Council I – Sunday, June 26, 2016

It was decided to delay the discussion regarding chapter relations until after chapter forum. Council also discussed the libraries transform. There are some ideas on how chapters could be involved. I noticed that only 4 Utah libraries have signed up, so there is an opportunity for more libraries. This will be a 3-5 year effort in ALA. There may also be an opportunity for programs or collaborative efforts.

Policy monitoring Committee

I have been asked to be on the Policy Monitoring Committee so I attended their meeting to familiarize myself with the issues and process.

Chapter Council Forum

Chapter Council Forum was then held at an earlier time and day so that the Chapter Relations Committee would have more input from the chapters. One of the major issues was resolution 40, Resolution Concerning the Role of Chapters in the American Library Association. COO proposal was discussed in regards to selections of chapter relations committee and having 8 of the 11 members with chapter experience. COO passed the resolution and will be passed on to Council. We were reminded to include chapter experience on the volunteer form. We discussed and re-wordsmithed the resolution to hopefully make it more acceptable. Discussion then on

libraries transformed including one where Wisconsin photographed legislature members holding a large library card and then had a professional picture for each library. It was the understanding of the group that libraries transform could be modified to localize it, as long as they meet the guidelines of the program. Materials may be available for conferences as long as they are requested early enough. It was also discussed that sometimes school librarians feel they are not represented by Chapter Councilor since many states have separate associations.

<u>Interest Group for Librarians at For-Profit Institutions</u>

Most of the attendees were from colleges. Trend is for many colleges to be closing. Feeling is that because they are in a for-profit institution they are not as critical as nonprofit libraries. They use online libraries for students, e-books, databases, work from home, etc.

Council Forum II

Council Forum: discussion about the chapter's resolution. Mostly positive comments about the revisions were made. We then discussed a resolution regarding gun violence and some good discussion was a result.

Council II

Voted to approve a change to require chapter experience in order to serve on the Chapter Relations Committee. Voted to support a resolution encouraging UN depository system to be more affordable and transparent, especially for emerging countries. Voted to clarify that Councilors could not run for two positions at the same time, simply a clarification of existing requirements. Hear the report from the Freedom to Read Foundation. Heard the progress concerning improving accessibility at ALA conferences. Referred the Chapter Relations issue to a working group, members to be appointed by the ALA incoming President. Heard that attendance at Orlando is down but was anticipated though under projections. Opinion was expressed that Orlando may not be the best choice, in light of recent developments that might have been a deterrent to some.

Chapter Relations Committee II

Chapter Relations Committee: discussed the actions that were taken in Council regarding referring the resolution to the working group. Heard a report from the ICLAE regarding Executive Directors actions and discussion. ALA public awareness office presented info about Libraries Transform. 3000+ libraries are signed up. Campaign is ready to move from the sign-up stage to the next step, implementation. Suggested to look at Ohio and what they did for their legislative day using the program. Also thinking about regional cohort program so that libraries in the same area can support each other. It was reiterated that states can modify the transform logo and theme; their guidelines are on the website. Academics can use toolkit to help with accreditation by showing measurements in student success, graduation rates, etc. The office has speakers available for conferences, workshops, etc. 8 Utah libraries have signed up as of June 16. West Virginia has experienced with severe flooding and will eventually need library materials. New advocacy webinars will be available in July. FREE! LITA is working on establishing state chapters (verify, hard to hear speaker). Slides are available for program on

planning a conference. Ideas were shared on what programs could be offered at midwinter, such as legislative day ideas, library transformed best practices, how to restructure, using volunteer members vs professionals for lobbying or conference planning.

Council III

Passed memorials and tributes. Heard the Treasurers report (estimates of income) and election results. Voted to defer a resolution supporting the establishment of deaf cultural digital library to 2017 Midwinter. Voted to support resolution supporting adoption of the Marrakesh treaty in order to make more print materials available to the blind community. Voted to support a resolution commending supporters of school libraries. Voted to support resolution on equity for school libraries for the DOE rule making. Voted for resolution regarding funding for school librarians, certification for librarians, research for literacy levels, electronic resources, funding for digital databases, and encouragement for application to grants. Heard the report from the Intellectual Freedom Committee report. There was an extensive discussion regarding if we should defer the resolution affecting gun violence effecting libraries, library workers, and library patrons. There was great passion and emotion in the discussion. Voted to defer the resolution so that it could be better crafted and discussed. Motion passed 85-53. New journal on intellectual freedom available, available online free, for now. New voices initiative encourages more diversity in publishing. Voted to support resolution regarding an interpretation of religion in libraries. Final attendance figures are 16597.
