### ULA Bylaws, Article 17, Section 2B: Round Tables

- a. A round table must have no fewer than fifteen (15) members.
- b. If a round table has fewer than fifteen (15) members at the close of the annual conference, the Executive Secretary will so notify the Executive Committee of the Board of Directors, which in turn will so notify the steering committee of the round table. If the membership of the round table does not increase to at least fifteen (15) before the close of the current membership year, which is December 31, the Board of Directors at its regularly scheduled quarterly meeting in February shall declare the round table dissolved. Members of the association wishing to re-establish the round table may not file a petition to do so with the Board of Directors until after the close of the next annual conference of the Association.
